




## Invitation to Bid for Improvement of Malaca Road (Asphalt Overlay) @ Brgy. Malaca, Urbiztondo, Pangasinan

1. The **Municipality of Urbiztondo**, through the **20% Development Fund & GAD Fund** intends to apply the sum of **₱ 3,113,190.88** being the Approved Budget for the Contract (ABC) to payments under the contract for **Improvement of Malaca Road (Asphalt Overlay) @ Brgy. Malaca, Urbiztondo, Pangasinan** with Project Identification Number **infra2023001**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Municipality of Urbiztondo** now invites bids for the above Procurement Project. Completion of the Works is required **4 Calendar Days/February 24, 2023**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Municipality of Urbiztondo** and inspect the Bidding Documents at the address given below from **8:00 A.M. to 5:00 P.M.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 24, 2023 to February 13, 2023** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱ 5,000.00*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees be presented in person.
6. The **Municipality of Urbiztondo** will hold a Pre-Bid Conference<sup>1</sup> on **February 1, 2023 at 9:00 A.M. at BAC Office, Municipal Hall, Urbiztondo, Pangasinan**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before **February 13, 2023 at 9:00 A.M.** Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **February 13, 2023, 9:00 A.M. at BAC Office, Municipal Hall, Urbiztondo, Pangasinan.** Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Municipality of Urbiztondo** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
